SEASONAL PERMITS (must maintain 1 resident for every 2 guests at all times)

NON-EXCLUSIVE USE OF HCCA PARKS (need HCCA approval):

Groups exceeding 50 people

TIME	51-100	101-500*	501-1000*	1001-1500*

8+ Hours	\$300	\$600	\$900	\$1200

*Groups exceeding 200 people will be required to hire Deputies for parking and crowd control

GUIDELINES

- Only Hunter's Creek residents with valid Hunter's Creek ID cards may apply for a permit
- All seasonal permitted groups must maintain a one resident to two guests ratio at all times
- Permits will be accepted no more than 30 days before the first day of the applicable season
- Permits are limited to a total of 3 hours per week per requesting group
- Permits are limited to the hours between 8:00 a.m. and 10:00 p.m.
- Residents whose account is in arrears for any reason or do not possess current Hunter's Creek identification cards will be held for action until resolved
- HCCA reserves the right to revoke any permit for violation of Park Rules and Regulations.

- Submitting false or inaccurate information may cause a permit to be revoked
- HCCA reserves the right to close any facility without notice due to weather, field conditions, special events
